REGISTERED ABORIGINAL PARTIES

Registered Aboriginal Parties (RAPs) are representative corporations, inclusive of all Traditional Owners of an identified Country area. Before being granted RAP status, they have undergone a rigorous review process, in which their relationship to Country, the inclusivity of their membership and proven link to Apical Ancestors have been considered. RAPs have important roles and functions as the decision makers for their Cultural Heritage over an appointed area of Victoria. Their core functions include: evaluating Cultural Heritage Management Plans, assessing Cultural Heritage Permit applications, making decisions about Cultural Heritage Agreements, providing advice on applications for interim or ongoing Protection Declarations, entering into Aboriginal Cultural Heritage Land Management Agreements with public land managers, nominating Aboriginal intangible Heritage to the Victorian Aboriginal Heritage Register

There are 11 Registered Aboriginal Parties (RAPs) that cover approximately 75% of Victoria.
